

Annual CCR Fugitive Dust Control Report

East Kentucky Power Cooperative

October 6, 2022 - October 5, 2023

INTRODUCTION

East Kentucky Power Cooperative (EKPC) is required to prepare this Annual Coal Combustion Residuals ("CCR") Fugitive Dust Control report in accordance with 40 CFR §257.80(c). This report covers the period between October 6, 2022 and October 5, 2023. The report includes:

- A description of the actions taken by the owner or operator to control CCR fugitive dust.
- A record of all citizen complaints, and
- A summary of any corrective measures taken.

A list of the fugitive emission sources that have been identified in the Fugitive Dust Control Plan for Spurlock Power Plant, a brief description of the source, and a list of actions taken to control CCR fugitive dust during the reporting period are found in Table 1.

EKPC has established a webform on the CCR Rule Compliance Data and Information website to log citizen complaints. Complaints received are manually logged on a Microsoft Excel worksheet that is used to record all complaints, all resolutions to those complaints, and, if necessary, corrective measures during the reporting period. A copy of the worksheet is included in Table 2. No citizen complaints associated with fugitive dust were received during this reporting period.
